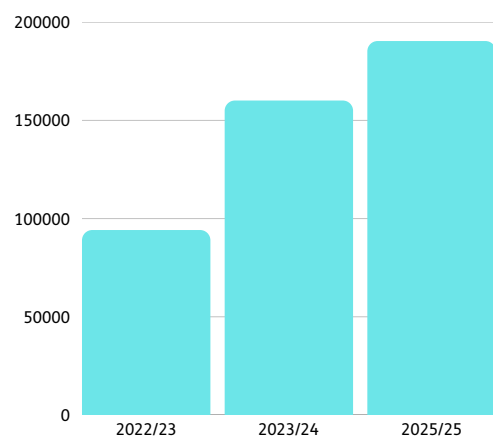
Prescott Group's financial statements for the year ending March 31, 2025 have been prepared by Grant Thornton Chartered Professional Accountants.

In 2024-25, we saw a steady increase in the success of our social enterprises with a 6% increase in revenues. We also received a one-time payment from the Department of Opportunities and Social Development to reimburse Prescott reserves for previous years' wage shortfall lending to a surplus at the end of the year.

Since 2022/23, wages earned by people with disabilities through Prescott's social enterprises and programs have increased by \$96,228—putting more income directly into the hands of those we support and reflecting our commitment to fair pay and meaningful work.



We are very grateful to the Province of Nova Scotia for its ongoing support. Government funding made up 78% of Prescott Group's total revenues in 2024/25.
